Good Afternoon

Lincolnshire Integrated Care Board (LICB) is disappointed with the outcome of the viability assessment and the decision not to award Section 106 funding for healthcare provision. Details of the NHS requirements are set out within the Countywide Supplementary Planning Document, which is available to applicants prior to the submission of any planning application.

Given the additional population growth associated with the development, and the resulting increased demand for healthcare services, the ICB maintains that the original request met the criteria set out in the Town and Country Planning Act 1990, specifically that the contribution must be:

- necessary to make the development acceptable in planning terms;
- directly related to the development; and
- fairly and reasonably related in scale and kind to the development.

In relation to each of these criteria, the LICB’s position is outlined below:

- The ICB considers that the absence of funding for this scheme will fail to support the additional capacity required at Munro Medical Centre and/or Beechfield Medical Centre.
- The requested contribution is directly related to the anticipated increase in population arising from the development.
- The request is proportionate to the scale and nature of the proposed development.

In summary, the removal of this funding, which is intended to mitigate the impact of the development, will place additional pressure on NHS budgets.

We would be happy to discuss this matter further if required.

In short, this concludes that:  
“In summary, in keeping with the applicant’s conclusions, and despite various adjustments in our appraisal, our model also demonstrates that the scheme is unable to viably support any affordable housing / S106 contributions (although our model does still retain the construction of the Community Centre)”.

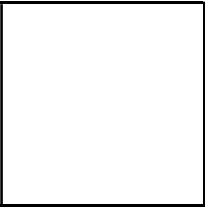
