LINCOLNSHIRE COUNTY COUNCIL

ROAD TRAFFIC REGULATION ACT 1984 TEMPORARY RESTRICTION TO TRAFFIC (HOLBEACH BANK/HOLBEACH ST MARKS – SLUCE ROAD/OLD SLUCE ROAD)

NOTICE IS HEREBY GIVEN that LINCOLNSHIRE COUNTY COUNCIL intends to make an Order on Sluce Road & Old Sluce Road to allow for works to be carried out on or adjacent to the road.
