### **3. Strategy**

3.1 The BNG strategy follows the biodiversity gain hierarchy outlined in Paragraph 008 of the BNG Planning Practice Guidance:

- Avoid biodiversity loss: The development footprint avoids high-distinctiveness habitats and retains existing mature hedgerows where appropriate.
- Mitigate impacts: Existing trees are to be retained.

- Enhance and Create On-site: Five additional trees are to be planted.
