This submission seeks to make a non-material amendment to condition 2 and 3, which relates to the approved plans. The primary change concerns the design and specifications of the Battery Box, as the project now involves a different Original Equipment Manufacturer (OEM). While the OEM has changed, the capacity of the units and the overall operational functionality of the system remain entirely unchanged. The system will continue to function as originally intended, importing electricity during periods of low demand or high renewable energy availability and exporting it during peak demand. The core objectives of the project—providing a flexible and decentralised energy storage solution—remain unaffected.
