Description of Proposed Works

Please describe the proposed works

The proposed works is for the erection of a wall and gates to the driveway at the front of the property. The wall will consist of a 1.2 meter high wall with pillars reaching 1.6 meter at 6ft intervals. In between the pillars will be railings. The railings will be 400mm high and 1800mm in width, steel and black powder coated. The gates to the driveway will be inline with the design of the railings and with a total height to match of 1.6 meter. The wall be constructed in the same brick as the main property. The gates to the driveway will be sliding gates to the right of the property sliding right as you entrance.

The wall will be 2 meters from the curb edge of the highway. There will be no change in ground level.

To the left of the property there is a bush currently approx 4ft in height slightly obscuring the adjoining road entrance to Manor Farm. The erection of the wall and the railing will improve the visibility to the main road (fen Road) and Manor Farm entrance access.
