Installation of 208x 450w Solar PV panels on South West facing roof of new agricultural building. Total system capacity is 93.6 kWp. System includes 2x 40.0 kW Solis 3-phase inverters & Pramac 188.0 kWh battery storage system. Estimate annual solar generation is 78,834 kWh to contribute towards overall electricity requirements.
