Spalding Gentlemen's Society
Full Planning and LBC Application

I'm writing on behalf of the Spalding Gentlemen's Society Museum, to apply for full planning and listed building consent.

We recently submitted for S73 planning and LBC (on the 10th July 2025). However, following receipt of an invalidation letter relating to the LBC application, and further clarification by telephone with the council, we understand these applications must be full applications, as we have included information relating to outstanding conditions

Following a helpful telephone call with one of your colleagues, we understand we can re-apply via email, as no one from the council has yet reviewed any of the documentation, therefore the **fees relating to the S73 planning application** (paid today 17th July 2025) **can be transferred to the full planning application**. We understand there is a £2 difference in these fees, which we have paid directly to the council, via the website, using the reference 'H16-0684-25'.
