Environment Agency position

We have **no objection** to the proposed development; however, we would like to draw your Authority's and the Applicants attention to the following information.

Foul drainage

It is a requirement that the package treatment plant is used in accordance with the manufacturers guidelines and is emptied on a regular basis. We recommend regular checks are made to ensure the package treatment plant is working effectively and polluting matter is not entering the watercourse.

Environmental permitting

The proposed poultry operation will require a permit under the Environmental Permitting Regulations (England and Wales) 2016. We will be including the following key areas of potential harm when making an assessment for the permit:

Calls to 03 numbers cost no more than national rate calls to 01 or 02 numbers and count towards any inclusive minutes in the same way. This applies to calls from any type of line including mobile.

- Management including general management, accident management, energy efficiency, efficient use of raw materials and waste recovery
- Operations including permitted activities and operating techniques (including the use of poultry feed, housing design and management, slurry spreading and manure management planning)
- Emissions to water, air and land including to groundwater and diffuse emissions, transfers off-site, odour, noise and vibration, monitoring
- Information records, reporting and notifications

Emissions to land, air or water (including odour and noise that are generated outside of the installation boundary) will not be addressed by the permit. This will apply to the following activities:

- emissions from landspreading of slurry and manure (the permit will set controls for landspreading of slurry and manure but it will not assess the effect of emissions from landspreading)
- the transport of manure from the installation to fields using a tractor and trailer
- the transport from the installation through permanent or temporary pipework of slurry or dirty water used for irrigation
- the provision of office and toilet facilities
